

### Article 1 : Scope

All our sales are governed by the present general conditions of sale which prevail over any conditions of purchase, except in the case of express derogatory stipulation.

### Article 2 : Price

The applicable prices are in force on the day the order is taken, and appear on the opposite scale, in euros. They are understood to be "ex cellar", transport being at the buyer's expense. Unless otherwise agreed between the parties, payment is made at the time of order. No discount will be granted in case of early payment. In application of the legal provisions, any payment made after the date of payment appearing on the invoice will lead to the payment of late payment penalties, the amount of which is equal to three times the legal interest rate. These penalties are payable without the need for a reminder. In addition, all collection costs will be charged to the buyer.

### Article 3 : Retention of title

The seller retains ownership of the goods sold until full payment of the price by the customer, in principal and accessories. However, from the moment of delivery, the risks of loss or deterioration are transferred to the buyer.

### Article 4 : Delivery

The delivery is made :

- either by direct delivery of the goods to the buyer
- or at the place indicated by the buyer on the order form.

Our wines travel at the recipient's risk, even in the case of carriage paid shipping. The seller cannot be held responsible in the event of damage, loss, theft or defective parcels. Consequently, customers are invited to check the parcels on receipt and to notify any reservations to the carrier, by registered letter, within three working days of receipt of the goods.

### Article 5 : Litigations

Our sales are subject to French legislation. It is expressly attributed competence to the Tribunal de grande instance of the seller's domicile.

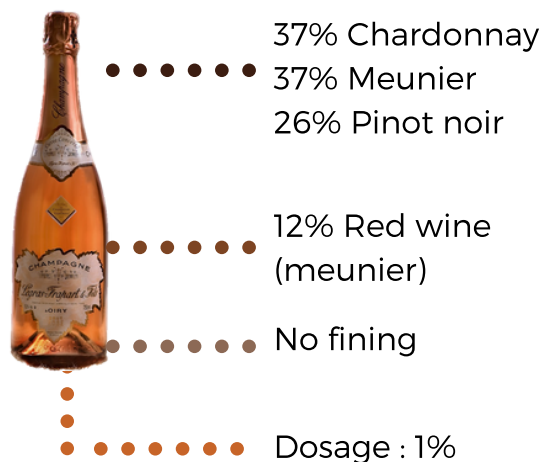
